IMPORTANT UPDATE

New CMS Patient Safety Structural Measure

On August 28, 2024, the Center for Medicare & Medicaid Services (CMS) published a new Patient Safety Structural Measure requiring acute care hospitals to prioritize patient safety or risk reduced Medicare payments in FY27.

What this means for acute care hospitals:

- This attestation-based measure is effective with the CY25 reporting period.
- Hospitals can score up to five points for implementing 25 patient safety practices across five domains.
- The score will be publicly reported through Care Compare on Medicare.gov starting in October 2026.
- Starting in FY27, payment for healthcare services will be reduced for hospitals that do not submit their attestation data.

How the measure will work:

The measure consists of 25 best practices across five domains that hospitals must attest to, including the following:

1. Leadership Commitment Eliminating Preventable Harm

- The Board ensures adequate resources and is notified within three days of a serious event
- Conducts a system-wide safety assessment and execution of patient safety initiatives and operations

2. Strategic Planning and Organizational Policy

- Follows a strategic patient safety plan with safety goals and metrics
- Has written "Just Culture" policies and protocols
- Develops safety curriculum/competencies for all staff

3. Culture of Safety and Learning

- Conducts an annual/biannual hospital-wide safety culture survey
- Has a dedicated team that conducts safety event analysis
- Implements high-reliability practices and participates in large-scale learning networks

4. Accountability and Transparency

- Works with a Patient Safety Organization
- Tracks, reports and publicly posts patient safety metrics
- Follows a defined evidence-based communication and resolution program

5. Patient and Family Engagement

- Has a Patient and Family Advisory Council
- Provides patients with comprehensive access to their medical records and support to interpret information
- Supports the presence of family and designees as essential members of a safe care team
