# MEMORANDUM

- TO: Hospital Administrators Hospital Pharmacists Hospital Emergency Response Coordinators Regional Hospital Coordinating Centers Non-Hospital Infusion Sites
- FROM: Ashley Thoele, MSN, MBA, RN Division Chief, EMS and Highway Safety
- RE: Antibody Therapy Allocations to Hospital and Non-hospital Infusion Sites

Biweekly antibody therapy allocations have previously included Regeneron's antibody cocktail casirivimab/imdevimab and bamlanivimab for the treatment of mild to moderate coronavirus disease. The cycle 11 allocation of bamlanivimab includes an allocation 1240 vials to Illinois hospital and non-hospital infusion sites. This will be the final allocation of these two products made by IDPH. Any current requests made via email request or the survey will be processed this week. The Regeneron product is in the process of being repackaged and allocations or ordering can begin again soon. Please see <u>NEW</u> changes below regarding direct ordering for these two products.

IDPH has also received questions from hospital and non-hospital infusion sites about new monoclonal antibody therapies. At this time, direct ordering will be available for the two products (bamlanivimab and casirivimab/imdevimab). Any future availability of additional or new products will be communicated when they are made available as well as the process for receiving new products and whether that will be through allocations or direct ordering.

By accepting and receiving allocations for monoclonal antibody therapy, healthcare facilities agree to follow the Emergency Use Authorization for administration and provide utilization as explained below.

### New Changes in Requesting Monoclonal Antibody Therapy- Direct Ordering Now Available

Beginning immediately infusion sites (hospital and non-hospital) may order bamlanivimab or casirivimab/imdevimab directly from the distributor AmeriSource Bergen. Infusion sites can stop using the form and survey links provided for ordering by IDPH and begin ordering directly from AmeriSource Bergen.

#### **Process overview:**

- As of February 3, infusion centers, specialty physician offices and urgent care centers (based on classes of trade), are able to order bamlanivimab (Lilly) and/or casirivimab/imdevimab (Regeneron) monoclonal antibodies for their facilities at the link listed below
- Sites will be required to:

- Provide ABC with a board of pharmacy license or physician letter of authorization
- Attest to their designated class of trade and that they will administer the authorized product according to the terms of the FDA issued EUA
- Provide utilization data via either TeleTracking or NHSN
- Sites can order product based on established minimum amounts; subsequent orders are subject to a maximum amount based on previous orders and utilization
- State departments of health will be informed of therapies ordered within their jurisdictions for awareness.

## **Required utilization reporting:**

- Weekly reporting on these therapeutics is *required every Wednesday* through HHS Protect, TeleTracking, or CDC's National Healthcare Safety Network (NHSN) depending on facility type
- Instructions are included at the bottom of the ABC order form, and included here for reference
  - To improve availability of treatments for Monoclonal Antibody (mAb) therapies for COVID patients across the nation, the federal government requires entities receiving shipments of mAb treatments to provide weekly reports of mAb treatments administered and stocks on hand through one of the following reporting mechanisms:
    - For Hospitals, mAb therapeutic data reporting is included in the <u>COVID-19</u> <u>hospital data reporting</u> as described in US Dept. of Health and Human Services FAQ/Guidance on linked here: https://www.hhs.gov/ sites/default/files/covid-19-faqshospitals-hospital-laboratory-acute-care-facility-data-reporting.pdf
    - Skilled Nursing Facilities / Long Term Care Facilities are requested to provide data through the CDC's NHSN data system at a future date (Guidance forthcoming)
    - All Additional Facilities such as Dialysis Centers, Home Health Services, Oncology, and Infusion Centers, are required to <u>provide the requested data</u> through the following portal: https://teletracking.protect.hhs.gov/

First-time users will receive enrollment and reporting instructions in an e-mail from protectnoreply@hhs.gov with the subject line of "Invitation: HHS TeleTracking COVID-19 Portal." This email provides step-by-step instructions to access the Portal for the first time.
