- RE: Cycle 05 Antibody Therapy Allocations to Healthcare Partners

Cycle 05 Antibody therapy were allocated the week of 10/11 to 10/17/2021 as below. It includes the addition of Sotrovimab as well as Regeneron's antibody cocktail casirivimab/imdevimab and the bamlamnivimab/etesivimab products for the treatment of mild to moderate coronavirus disease. In Cycle 05 the State of Illinois was allocated 2020 patient courses of bamlamnivimab/etesivimab and 1680 patient courses of Regeneron's casirivimab/imdevimab and 1110 patient courses of Sotrovimab.

State Allocation Process will consider the following metrics:

- Prior utilization per teletracking reports
- Case rate by county
- Available ICU beds in COVID Region (not all counties have ICU beds)
- Social Vulnerability Index by county (High vs. Low SVI)

Update regarding shipping delays:

- Many sites got "unexpected" shipments this week. AmerisourceBergen cleared a bunch of held orders due to credit or licensure issues this week and it released prior cycles orders. In doing so, some holds released twice from prior "retries".
- Please consider using bamlanivimab/etesevimab IV in place of regencov IV for infusions.
- IV Regeneron formulations may also be used for Subcutaneous dosing- please see attached.

Any vials not accepted by healthcare partners will be re-allocated to other healthcare providers based on urgent requests to IDPH. Note: A request does not guarantee the amount of

Mab requested will be provided or that the request will be approved. Priority will be based on areas of the state with the greatest need.
